We need a response from every member available when the tones drop, but if you cannot come to training, are you really helping us out on scene, or are you becoming a greater liability?

The Answer: You are becoming more and more a liability. You have to come and train with the department. If you were to get hurt or even worse, the first thing that is going to be looked at is your training records. Did you 1) Have the training to do what you were doing at the time? Or 2) Did you have enough continuing education hours to meet the minimum requirements.

KCFS is committing a lot of time and resources to ensure that adequate amounts of training Are available to our members. We will continue to provide opportunities to members to catch and make up training hours at district training. Do not get hung up on not making it to your assigned District Training. Make it a point to go to a different district just to see how they train, or maybe some obstables that they may face.

# Fire Alarm & Suppression Systems

Chief Bullard will present a Training Series on Suppression Systems and Alarm Systems this month in the EOC just before Medical Training. This will be good information for the amount of alarms that we respond to on a regular basis.

# Medical First Responder

FF/Paramedic Leanne Treiber will be going over some of our medical response procedures and will begin to gear us in a new direction for medical training. This will be very important because typically based on our overall responses, Medical in nature makes up approximately 80% of our call volume.
